1. A National Police Certificate (if you do not have a current WA Firearms Licence).
2. If you are already a member of SSAA or WAPA, your membership number is required.
3. If you hold a current WA Firearms licence, a copy of your paper licence is required.
4. If joining as a Pensioner, a copy of your Pension Concession Card is required.
5. Payment of a one-off (non-refundable) nomination fee.

Important Information You Need To Know

New Memberships: Applicants need to apply for membership to the Club using this membership application form by handing it to the Club Secretary with your nomination fee, a National Police Certificate or a copy of their current WA Firearms Licence.

Renewal of Membership: Applicants need to provide an updated record of all personal details and a list of all Firearms to be supported by Port Bouvard Pistol & Small Bore Rifle Club.

Safety: Safety is paramount at our Club and on our Ranges. Attention to safety has made pistol shooting one of the safest sports. A Range Officer (RO) is responsible for safety on the range. All shooters and visitors must obey the Range Officer's instructions at all times. Eye protection, hearing protection and enclosed footwear must be worn at all times when on the Range.

Minimum Activity Requirements: To retain SSAA or WAPA support for a firearm, the shooter must participate in a match for which the firearm was nominated at least once every 8 weeks. Participation is defined as submitting a score for a formal match conducted at Club, State, and National or International level.
